

# Declaration regarding data protection according to the General Data Protection Regulation Applicants

The protection of your personal data is a matter of specific concern to the Medical University of Vienna.

With this declaration regarding data protection we would like to inform you about the fundamental aspects of data processing in the context of your application.

## 1.1 Data processing

In the procedure of your application the following personal data corresponding to the application form are collected and processed:

- Identity data (e.g. name, nationality, date of birth, sex, social security number)
- Contact details (e.g. address, e-mail-address, phone number)
- Applicant's data (e.g. education, profession, previous work experience, language skills, EDP-skills, other skills, military- or community service fulfilled, PhD-study at the Medical University of Vienna (planned or current))
- Reduction of earning capacity, if applicable degree of disability (voluntary disclosure)
- Organisational unit
- Next possible entry date

Furthermore, any other information that you disclose and you're likely to transmit, such as letters of application, CVs, references, certificates, etc., will be processed by us.

The collection and processing of your personal application data is carried out solely for the filling of vacancies within the Medical University of Vienna. Your data is only transferred to the responsible internal units in charge of the specific application process. In the event of a successful application, the data and documents submitted by you will be further processed for the purposes of the employment relationship.

In general your personal application data are processed until the end of the application procedure. In the event of an unsuccessful application, your data and documents will be stored for seven months after completion of the application process. This does not apply if deletion is prohibited by legal regulations, if further storage is necessary for legal evidence or if you have explicitly agreed to a longer storage.

Data processing is carried out according to the legal provisions (Art. 6 Para. 1 GDPR), namely on the **legal basis**:

- Consent (litera a)
- Implementation of pre-contractual measures (litera b)

• Fulfillment of legal obligation (litera c) (according to Universitätsgesetz 2002 - UG)

By submitting the application to us you consent to the processing of your data for the purposes of the application procedure (consent pursuant to Art. 6 (1) lit. a or Art. 9 (2) lit. a GDPR). If special categories of personal data within the meaning of Art. 9 (1) GDPR are voluntarily disclosed within the application procedure, they are additionally processed in accordance with Art. 9 (2) lit. b GDPR (e.g. health data, such as notification regarding degree of disability, religious beliefs).

Consent given can be withdrawn at any time and your application will be withdrawn as a result. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal.

To process your application the submitted data has to be electronically stored and processed. The provision of the personal data is therefore necessary for this data processing. In case the provision of personal data for this data processing is given by law or contract or necessary for contract closing, the non-provision of data may result in non-fulfillment of the obligations of the Medical University of Vienna towards you.

## 1.2 Your rights

You are basically entitled to the **right of access**, **rectification**, **erasure**, **restriction of processing**, **data portability** and **objection**.

If you are of the opinion that the processing of your data is violating the data protection law or your legal data protection interests have been violated in any way you may issue a complaint to the supervisory authority (Österreichische Datenschutzbehörde, www.dsb.gv.at).
