

## Announcement of ten § 99 para. 4 Professorships at the Medical University of Vienna

The MedUni Vienna, one of largest medical universities in Europe, constantly strives to promote outstanding academic staff. According to the performance agreement with the Federal Ministry of Education, Science and Research (A4.3.4), ten Associate Professors of the MedUni Vienna have the possibility to apply a "shortened appointment procedure" in accordance with § 99 para. 4 Austrian University Act 2002 (UG 2002) to gain a professorship. The appointment is linked to a permanent employment contract as a university professor.

Qualification requirements:

1. Doctoral/PhD degree (in case of physicians PhD, Dr.scient.med. or comparable domestic or foreign degree, eg a degree in doctoral studies in medicine according to A201/N201)
2. Internationality by work experience or professorship at an external, preferably foreign, research and/or teaching institution or international activities
3. Autonomous teaching including examination and main supervision of doctoral students and graduands
4. International reputation as a researcher in the relevant field and consistently high academic performance
5. Successful and continuous acquisition of competitive third-party funds

Applicants are expected to be competent in interdisciplinary and multidisciplinary collaboration within the research clusters and center structures described in the University's Development Plan, active participation in teaching, a commitment to the quality of results orientation and a willingness to develop personal management skills.
